I am writing to inform you that Peterborough City Council is consulting on the [Further Draft Local Plan](#), the second stage in the preparation of a new Local Plan for Peterborough. This is an important document as it will determine what Peterborough will look like in the future and how it will become an even better place to live, work and visit. The Further Draft Local Plan sets out criteria based policies that address the key issues in Peterborough. It also includes specific allocations for new development.

Consultation on the Local Plan will take place between **16 December 2016 and 9 February 2017**.
